- 1. The JPII Hall will be opened one hour before the event.
- 2. The JPII Hall & Plaza have a designated setup. Please see the attached floor plan for the boundaries of use (JPII Hall) and the setup.
- 3. Every user has the responsibility to ensure that the set inventory is kept in place and in order.
- 4. All tables and chairs plus equipment cannot be removed. If moved, they should be returned to their original location at the end of the day/event.
- 5. Bookings must be done by completing the attached form. Amount payable as stated above.
- 6. One month's notice must be given for any cancellation or \$300 will be forfeited.
- 7. Disposal of all waste must be done after the hall's usage. Caterers are to remove all trash from the church premises.
- 8. Do not leave leftover, raw, or cooked food in the premises.

## **STEP 1 -**

Set your wedding date and approach your presiding priest

Book your wedding date/time with the priest and confirm availability of the Church with the Parish Secretariat at least one year before your wedding date.

Complete the Wedding Booking form and submit your form to the Parish Secretariat.

- Booking for Reception in the Church at JPII Hall. Please contact the Parish Secretariat.
   (Cf. "Use of Church JPII Hall: Terms and Conditions as stated in the application form)
- No Weddings will be allowed on the following days at SFX:
  - Lent and the weekend before Christmas
  - On days of Obligation
  - The Weekend on the feast of St Francis Xavier
  - Sundays & Public Holidays (unless approved by Parish Priest)
- No throwing of Confetti, Rice Grains, Flower Petals and blowing of Soap Bubbles in the Church
- No Pets/Animals in the Church

#### STEP 2 -

Spiritual Preparation and learn Natural Family Planning (NFP) (>6 months)

- Attend either the <u>Marriage Preparation</u>
   <u>Course Singapore Catholic Archdiocese</u>
   <u>of Singapore (mpcsingapore.com)</u> or (CEE
   <u>https://ceespore.sg/</u>) at least 6 months or
   more before your wedding
- Journey with your presiding priest
- Sign up for an NFP course at http://naturalfamilyplanning.sg

#### STEP 3 -

Prenuptial Inquiry (6 months or more)

Make an appointment with the celebrant to go through the Prenuptial Inquiry at least 6 months before the wedding.

**If one party is non-Catholic**, you will need to liaise with a priest more than 6 months before your wedding date.

Documents you are required to hand over to the Celebrant at the Prenuptial Inquiry are:

- A recent extract of both your Baptism Certificates (for Baptized Catholics) You need to call up the Parish where you were baptized and ask them to issue you this extract for the purpose of this marriage.
- Certificate of participation from CEE or MPC
- ROM Certificate (If you have already gone through the civil marriage at the ROM)

# STEP 4 -

Register at ROM (0-3 months)

Inform the Registry of Marriages (ROM) of your intention to marry in this Church 3 months – 22 days prior to your wedding. Collect your certificate from ROM 3 days before the wedding and hand it over to the Parish Secretariat.

# STEP 5 –

Wedding Rehearsal

If you choose to have a rehearsal, it will have to be on a weekday (except Friday) after the evening mass. You will only be granted one rehearsal, and the duration of the rehearsal is limited to one hour. So please be punctual. If your presiding priest choose to have the rehearsal with both of you, he will brief on timing and what to do during the ceremony. Otherwise, our sacristan will offer you some tips/instructions as a guideline.

# INSTRUCTIONS BEFORE ACCEPTING A WEDDING BOOKING IN THE CATHOLIC CHURCH

We,	( <i>Bridegroom-to-be</i> ) and	(Bride-to-be)
acknowledge that:		

- 1. No wedding Mass or wedding Service will take place on Christmas, Epiphany, Good Friday, Holy Thursday, Holy Saturday, Easter Sunday, Ascension, Pentecost, Corpus Christi, and All Saints.
- 2. It is our duty to attend the Marriage Preparation Course (MPC) or Engaged Encounter (EE) or a preparation with a priest before our wedding.
- 3. It is highly recommended for us to attend the Natural Family Planning (NFP) sessions.
- 4. It is our obligation to apply for the ROM license to get married 3 months before our wedding date.
- 5. We should forward a copy of the ROM certificate with the certificate number, after the wedding ceremony, to the wedding parish.
- 6. If the bride-to-be is pregnant, the priest must be informed and the priest is to be provided with a medical certificate stating this.
- 7. The priest has read out and explained to us the impediments as listed in the prenuptial inquiry form.
- 8. The priest has advised us that if I am marrying a Muslim, we have to approach the Chancery for further instructions.

#### For the Priest to be certain of:

- Was it a valid baptism?
- In which Church was the party baptised?
- Is the wedding going to take place in a Catholic Church?
- Are there any other impediments?

The civil courts granting a nullity to a previous marriage does not mean that the couple is free to be married in the Catholic Church. The Catholic Church must grant the nullity of marriage or a dissolution before someone (even a non-baptised person) can be married in the Catholic Church.

A certificate of annulment or dissolution (Pauline Privilege or Favour of Faith) from the Catholic Church must be produced in cases where one party is a divorcee.

There have been instances where the couple denied being informed of the instructions and where couples have lied to the priest. Therefore, the following must be signed in writing.

The questions and the acknowledgement must be completed when the request for the wedding date is made. All bookings are to be made one year before the wedding date.

Priests are reminded to interview the couple separately with the other party waiting outside his office when the prenuptial inquiry is carried out. The solemniser is to conduct the prenuptial inquiry.
